Primary Routes of Entry: Inhalation, Skin Contact, Eyes Threshold Limit Value: Not Established Effects of Overexposure- Causes substantial but temporary eye injury. Harmful if absorbed through the skin. Conditions to Avoid: Inhalation of product mist may cause respiratory irritation. Ortho phenyl phenol has been shown to produce urinary bladder tumors in male rats and liver tumors in male mice fed exaggerated doses.

Do get in eyes, on skin or on clothing. Avoid inhalation of product mist. Do not spray on food or food

utensils.

Conditions Aggravated by Use: Preexisting skin; eye and respiratory disorders.

# **Emergency & First Aid Procedures:**

Eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses; If present; after the first 5 minutes; then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Skin: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

Inhalation: In case of respiratory irritation; move person to fresh air. Get medical attention if irritation persists.
